NON-PROFIT AND SOCIAL/HUMAN SERVICE

Philadelphia Insurance Companies (PHLY) has created the below charts to assist you in determining which Non-Profit and Social/Human Service application or supplemental should be completed for your risk. Please note that more than one application could be required to properly evaluate a particular risk.

Non-Profit and Social/Human Service Applications

Name of Application	When to use:
Adult Day Care	New and Renewal application for entities predominantly operating as an adult day care center
Human Service – Basic Application	Intended for Human Service risks with limited programs/operations with revenues < \$2,000,000
Human Service – Comprehensive Application	Intended for Human Service risks that are complex with multiple programs/operations with revenues > \$2,000,000
Human Service Renewal	Standard Renewal application for all human services organizations currently insured with PHLY
Non-Profit Non-Social Service	Intended for small, non-social service entities (i.e. chamber of commerce) currently not insured with PHLY
Residential Care Application	New and Renewal application for entities predominantly engaged in housing either elderly clients or Intellectually Disabled/Developmentally Disabled clients where continuous medical treatment is not required
Sleep Centers and Laboratories	New and Renewal application for entities predominantly engaged in sleep studies to diagnose and treat sleep disorders
Youth Group Organization	New and Renewal application for entities predominantly engaged in servicing the young (Boys'/girls' club, Boy/Girl Scouts, Camp Fire Councils, JCC, Indian Guides, etc.)
YMCA/YWCA	To be completed on all YMCA/YWCA risks

Non-Profit and Social/Human Service Supplementals

Name of Application	When to use:
Abuse and Molestation	To be completed if abuse & molestation coverage is requested
Adoption Supplemental	To be completed anytime adoption services are rendered
Camp	To be completed anytime there is a camp exposure to a risk
Foster Care Questionnaire	To be completed anytime foster services are rendered
HIV/AIDS Personal Care Residential Questionnaire	To be completed anytime personal care or residential services are offered catering to HIV/AIDS patients
Medical Professional	Primary medical professional liability for individual physicians, psychiatrists, dentist, etc.
Special Event – Liquor Liability	To be completed anytime there is a special event requiring liquor liability insurance
Special Events Questionnaire	To be completed anytime there is a special event scheduled to take place to which insured is requesting coverage
Water Slide Supplemental	To be completed anytime a water slide exposure is present

Name of Application	When to use:
Home Health Care & Hospice	To be completed for new business with Home Health Care and Hospice exposures
Home Health Care & Hospice Renewal	To be completed if renewing an entity with Home Health Care and Hospice exposures
Home Health Care New Entity	To be completed for new entities (organization that has been in business for more than six (6) months and less than three (3) years) with Home Health Care and Hospice exposures
Home Health Care Approved Franchise	To be completed for an approved franchise with Home Health Care risks
Home Medical Equipment	To be completed on all Home Medical Equipment risks
Home Medical Equipment Renewal	To be completed on all Home Medical Equipment risks when being renewed
Mental Health	To be completed for Mental Health exposures
Mental Health Renewal	To be completed for renewing accounts with Mental Health exposures
Substance Abuse	To be completed on all Substance Abuse risks
